

Product Safety Engineering Society Board of Directors Meeting



Minutes - Teleconference - October 3, 2006

All agreed that this enhanced our meeting.

1. 2006 Conference Update – Richard G. reported that as of now we have 14 vendors and 115 attendees, including two comps for speakers. Our Keynote Speaker #1 is Grant Schmidbauer of Nemko USA, Inc. Keynote Speaker #2 is Jack B. ReVelle, Ph.D., A Consulting Statisticial, ReVelle Solutions, LLC.

We would like to have at least twenty vendors, but may have to be satisfied with what we presently have. Everything is moving along okay.

Having CEUs depends on when Richard G. submits forms to IEEE HQ. The CEUs are dependent on the technical program which has now been finalized. For future reference, the technical program should very well structured and we just fill in the program with the appropriate presentations.

Richard is starting to set up the 2007 conference in the Denver area.

Richard said that we are well organized for conferences, but he is disappointed with the number of attendees.

Dan Arnold briefly went over our current budget situation, per the report submitted via email (and shown on the Microsoft Live Meeting.) Dan is concerned about our long-term viability without a bigticket income. It's vital that we build up a reserve of at least one-half our budgeted expenses.
