- o SRC
  - SRC Motion to TAB regarding PSES
  - TMC recognizes that Power [sic] Safety Engineering Society appears to be non-viable and recommends that unless it can demonstrate viability within 12 months, the society be dissolved or merged with another society.
  - Note that the name of the Society was corrected to Product Safety Engineering Society
  - Remarks made by SRC Chair were critical, remarking that the business plan has been changed and still not met; not met membership requirements; doesn't have a publication.
  - Survival depends on achieving 4 areas
    - Membership July 2010 1000 members; by Feb 2010 show that we are within 3% of this goal (970 members); provide a comprehensive membership development plan
    - Finance Remain off the financial watch list
    - Conference Generate a 24% surplus for conference proceedings by Feb 2010
    - Publication continue quarterly newsletters
- o TAB
  - Reviewed rules for Affiliate member
  - Explored accepting members at time of symposium registration at affiliate status
    - Discussed motion to change IEEE Bylaws to allow affiliates to vote and hold positions

# Membership
